This was a major action that closed two plants and a vendor location, resulting in improved scale and efficiencies which significantly improved production costs.
- ERP Implementation Lead the financial portion of the SAP ERP implementation for Hitachi GST, a subsidiary of Hitachi that was created when an acquired storage division was merged with an existing Hitachi storage division. Both divisions severed their connections with their legacy ERP systems, and implemented a new ERP system. My role included defining the financial business processes and driving consensus of implementation through system integration across all locations. Implementation of the new ERP system and transitional service agreements were completed successfully in time for day one operation.
